We hope you are able to enjoy the sunlight today. We know it is a difficult and highly uncertain time for many, and we are incredibly grateful for our OAR and the broader community.

In our last newsletter, we shared the potential impact and our fears of the President's freezing of federal funds. Our federal contacts shared that the unfrozen funding will not be guaranteed to remain this way and that multiyear grants may end before expected, potentially as soon as this September. Reports continue to trickle in about how a new freeze or removal of funding would impact vital public safety and justice programming, including likely cuts to programs and resources dedicated to mental health, substance use disorder, and reentry services. Others report that these freezes [will impact public defenders and legal service providers](#). If freezes or abrupt cuts occur, the news is not good for public safety, or for OAR participants and their families. We are trying to remain hopeful and will keep you updated.

There are some positive legislative updates in Virginia. The Virginia House and Senate [passed probation reduction bills](#), which will now be reconciled in committee. The bill allows people to reduce their probationary sentences if they meet certain conditions. [The Senate also passed another bill](#) restricting private management of prisons and jails unless approved by the General Assembly. The General Assembly passed a bill to improve protections in the criminal legal system [for people with intellectual or developmental disabilities](#), and both the Senate and the House [passed a bill prohibiting youth shackling](#).
