#### OAR's Bold Shift: Local Action for Systemic Change



Like many organizations navigating today's challenges, OAR is recalibrating our work to meet the urgent needs of those we journey with — people who are under constant attack by systems never truly designed with them in mind. We believe this is especially true for those most impacted by systemic injustice and generational disinvestment, facing deeply entrenched injustices across the housing, education, employment, healthcare, and criminal legal systems—compounded by relentlessly punitive policies.

We're shifting the way we engage in upstream work, placing greater emphasis on advocacy at the local level to push for meaningful alternatives to incarceration—especially as legislative change at the state and federal levels remains difficult under the current circumstances. At the same time, we remain deeply committed to the day-to-day, individualized programming that defines OAR—our downstream work—which continues to journey with and uplift those directly impacted by the criminal legal system. We believe this dual approach—addressing both immediate needs and systemic barriers—is essential to building lasting change for those most impacted.

We are excited to report that we have established a new partnership with the Urban Institute, a nonprofit, working to improve lives through evidence-based policy and practice. We are honored that OAR was selected as one of just 25 organizations nationwide for the Urban Institute's Catalyst Grant Program, which supports innovative efforts to use data and technology to advance racial equity and reform in the criminal legal system.

With this grant, we are launching a program to collect and analyze data from Arlington courts. We will focus on who gains access to bond, alternative sentencing, diversion, and other programs that connect people with critical resources while helping them avoid incarceration. Just as importantly, we'll be in court watching who gets excluded. We will examine disparities across race, income, gender, and other factors that shape legal outcomes. This information will inform our conversations with decision-makers and stakeholders in the legal system to push for meaningful reform.

Of course, this is a time-limited grant—just six months in duration. Once we've gathered our data, the work of advocacy, policy reform, and building new pathways must continue. To make the most of this opportunity—and in this critical moment—we'll need your support, now more than ever.


