Reentry Services: OAR journeys with individuals of all genders experiencing incarceration at the Arlington County Detention Facility, Alexandria's William G. Truesdale Adult Detention Center, and other facilities. OAR also supports individuals returning to or living in Arlington County, the Cities of Alexandria and Falls Church, the DC Metro region, and surrounding areas. During FY 2025, OAR had the privilege of journeying with more than 500 participants throughout their reentry process, along with their children and families. Our Peer Recovery Specialists and Community Navigators are individuals with shared lived experience and specialized training who collaborate with participants both pre-release and post-release. Alternative Sentencing and Diversion: Through OAR's Alternative Sentencing and Diversion programs, people of all genders and ages are able to remain with their families, continue working or attending school, give back to the community, and avoid the lifelong collateral consequences of incarceration. Through these efforts, more than 1,000 adults and 100 youth have remained in their communities rather than experiencing incarceration each year. Through partnerships with the Offices of the Commonwealth's Attorney in Arlington County and the City of Falls Church, eligible participants are referred to OAR in lieu of continued court involvement or fees. Education, Outreach, Racial Justice, Liberation, Advocacy, and Legislative Change: Our reputation and impact in the community have allowed us to convene leaders and mobilize them to move the needle forward on racial justice and liberation. We address incarceration, the legal system, and all systems upstream, calling out the injustice that permeates these systems, and we seek true justice. Since individuals make up systems, we also support people confronting the daily harm they can cause. We lift the voices of those who've experienced incarceration and racial and other intersecting forms of marginalization. Continued . . . . OAR's Alternative Sentencing and Diversion Program provides a restorative and community-based alternative to traditional prosecution for eligible individuals. The program is designed to interrupt cycles of incarceration, reduce harm, and support long-term stability by addressing the underlying needs that often bring people into contact with the criminal legal system. Participants engage in a structured diversion plan tailored to their individual circumstances, strengths, and goals. Plans may include community service, peer recovery support, coaching, connection to mental health or substance use treatment, employment and education support, housing stabilization, and other supportive services, as appropriate. OAR's approach to alternative sentencing and diversion is trauma-informed, participant-centered, and grounded in dignity and restoration. Rather than focusing on punishment, the program emphasizes responsibility, healing, and meaningful engagement with the community. Successful completion of the Alternative Sentencing and Diversion Program can result in charges being reduced or dismissed, helping participants avoid the long-term collateral consequences of criminal records. These outcomes improve access to housing, employment, and education, and enhance family stability, while reducing the likelihood of future system involvement. In FY 2025, more than 1,000 adults and 100 youth participated in OAR's alternative sentencing and diversion programs. By keeping people connected to their families, workplaces, schools, and communities, OAR's Alternative Sentencing and Diversion Program strengthens community well-being and increases public safety through prevention,

OAR also has a 45-point advocacy and legislative agenda informed by many stakeholders to focus our efforts for the coming years, including 1) reducing the incarcerated population by 20% each year, 2) decreasing the racial disparity in sentencing by at least 20%, 3) establishing expungement in Virginia, and 4) banning the box on all applications, including employment, housing, and educational institutions. OAR is also part of the PAPIS (Pre-release and Post-Incarceration Services) Coalition, a group of nine organizations. Together, we hire a lobbying firm to advocate for increased reentry funding from the state of Virginia.

guidance, he received coaching, tools, work attire, and renewed hope for his future. "Facing everything alone seemed daunting," he shared, "but OAR helped me believe I could do this." Abigail, a participant in OAR's Diversion Program, faced barriers to employment due to her background but remained determined to pursue a career in healthcare. Through OAR's coaching and peer recovery support, she secured a job offer and later obtained stable housing. Her success embodies OAR's trauma-informed and person-centered approach. Joshua, who was required to complete 100 hours of community service, faced health challenges that limited his physical capacity. OAR collaborated with a local nonprofit to design virtual volunteer opportunities so he could fulfill his commitment while prioritizing his well-being. He completed his hours early and shared his gratitude for OAR's flexibility and compassion. Damian began his journey with OAR through Community Service and later joined the Diversion Program. He said volunteering helped him "feel connected to something good." With OAR's continued support, he gained access to a licensed clinician, peer recovery specialists, and stable housing. He described OAR as "a place of good energy," saying it was the first time he had truly felt seen and supported on his journey. These reflections are shared in keeping with OAR's ethical storytelling practices, which prioritize dignity and privacy for every participant.
